**Andy Robinson Follows Up National Championship Run with a Ring
33-year old Round Rock, TX native earns his first Circuit ring.**

Bossier City, LA (November 12, 2013) – Andy Robinson had an excellent year on the WSOP Circuit last season. The 33-year old had three cashes including two final tables at the Choctaw Circuit last year, which earned him Casino Champion honors at the stop, not to mention a seat in the 2013 WSOP National Championship.

Robinson parlayed that National Championship freeroll entry into \$17,374 after finishing in 15th place. He is well on his way to earning yet another seat to the National Championship after coming out victorious in Event #5 at the Horseshoe Bossier City.

The \$365 No-Limit Hold 'em event drew 196 entrants taking their shot at the fifth ring of the Horseshoe Bossier City Circuit series. By the time the dust settled on Day 1, only nine players remained to battle it out.

Circuit ring winner Rex Clinkscales paced the field with 675,000 while Robinson came into Day 2 fourth in chips with 199,000. Robinson slowly built his stack up throughout the second day of play and eventually was able to secure his first ever Circuit victory.

For his win, Robinson pocketed \$15,289 and his first gold Circuit ring. The poker professional from Round Rock, TX will now turn his focus to earning consecutive seats to the WSOP National Championship.

With the 50 points he earned for winning Event #5, Robinson is now in a five-way tie for first in the Horseshoe Bossier City Casino Champion points race. There are still seven events left for Robinson to add to his points total and make a run.

You can bet that Robinson will do all he can to punch his ticket back to the WSOP National Championship.

Notes on the Event

- The final table took just over four hours to complete.
- Winner Andy Robinson finished 15th in last years WSOP National Championship.
- Runner-up Charles Clubb never had a Circuit cash before today.

With his victory, Robinson earns 50 points towards the Horseshoe Bossier City Casino Champion standings. The player who accumulates the most overall points in Horseshoe Bossier City's twelve combined gold ring tournaments earns the title Casino Champion and receives an automatic entry into the 2013-2014 WSOP National Championship, as will the winner of the Horseshoe Bossier City Main Event. All players who cash in ring events will receive points that apply to both the Casino Champion race and the season-long race to claim one of the at-large National Championship bids awarded to the top point earners throughout the season. EVENT #4: Sandeep Vasudevan defeated 203 players (\$365 NLHE) for \$15,835.
EVENT #5: Andy Robinson defeated 196 players (\$365 NLHE) for \$15,289.

With five tournaments complete, there are still seven more gold ring events remaining as the WSOP Circuit at Horseshoe Bossier City continues through November 18th.
