- Action Player Points ("APPs") earned during the promotion period will be counted toward the leader board. APPs count only from the time of opt-in and are not retroactive.

- Only APPs earned in cash games are counted toward this leader board.
- The top 100 players on each leader board will be displayed daily on the WSOP.com website based on APPs alone.
 - The multiplied score (see below) will be posted to the site at the end of the qualifying week. Multiplied scores could take up to 24 hours to be calculated and posted to the site.
- At the end of each qualifying week and, depending on how many consecutive days a player has earned APPs, the APPs will be multiplied based on the chart below. Players will not see the multiplied score until the end of the qualifying week, which is the blind leaderboard component.

- The multiplier will always be the one that most benefits the player.
 - Example: If a player earns 100-149 APPs daily for 5 days (4x multiplier) and then earns 150 APPS for 2 days consecutively (3x multiplier), they will be given the 4x multiplier.
 - As another example, if a person earns 500+ APPs for 2 days during the qualifying week (6.5x multiplier) and then earns 1-49 APPs for 5 days during the week (3x multiplier) they will be given the 6.5x multiplier.
- If there is a break in days when earning APPs, the patrons will only be eligible for the multiplier associated to the consecutive days played

during that week, to the benefit of the player. Streaked sessions with breaks in between are not summed together.

- Example: If a person streaked Monday and Tuesday and then didn't play again for the rest of the week, they would earn a 2day multiplier.
- Example: If a player streaked Saturday and Sunday, didn't play cash games Monday, and then played again Tuesday through Thursday, they would have a 3 day multiplier (if the three day multiplier is more beneficial to the player than the two day multiplier)
