$$\sqrt{\left(\frac{\text{buyin} * \text{entrants}}{\text{position}}\right)}$$

6. Points will be awarded to the top 50% of finishers in each qualifying Sit & Go tournament. For instance, in a 6-handed Sit & Go, the top three finishers will receive SNG Leader Board points. In a 9-handed tournament, the top 5 (rounding up) finishers will receive points.
