

2019 WORLD SERIES OF POKER® OFFICIAL LIVE-ACTION GAME PROMOTIONAL RULES
RIO ALL-SUITE HOTEL & CASINO, LAS VEGAS, NEVADA

Promotional period (the "**Promotion Period**") begins on Monday, June 3rd, 2019 at 12:00 a.m. and ends on Wednesday, July 10th, 2019 at 12:00 a.m. All times referred to throughout these Rules are Pacific Time ("PT"). As used herein, "**Casino**" means Rio Properties, LLC d/b/a Rio All Suite Hotel and Casino, located at 3700 West Flamingo Road, Las Vegas, Nevada 89103.

GENERAL RULES:

1. The World Series Live Action Promotion the "**Hot Seat \$500 Hourly Giveaway**" shall be referred to as the "**Promotion**" throughout these Official Rules, which shall be occurring daily in the Live-Action Game Section in the Pavilion Convention Room at the Casino, on all eligible and designated Texas Hold'em Poker games.
2. To be eligible to enter this or win this Promotion, participants and or players (the "**Participant(s)**" or "**Player(s)**") must be at least 21 years of age and must provide proof of age with valid picture identification (driver's license, state identification card, or military identification card). If Participant is not a U.S. citizen, a current passport, government issued driver's license, or alien registration card is required. A Participant's entry into a Promotion shall be voided if the Participant is under the age of 21 years.
3. Casino reserves the right to refuse any individual entry into any Promotion, in its sole and absolute discretion.
4. Void where prohibited or restricted by law.
5. Promotions are subject to all applicable federal, state, and local laws and regulations, including gaming regulations, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities.
6. Except where prohibited by law, Participants agree to allow Casino unconditional use of their name and likeness for promotions/advertising and announcements without compensation, consideration, notice review, or further consent.
7. Winners are responsible for any and all taxes, licenses, registrations and other fees, as applicable.
8. Winnings may be subject to reporting and withholding pursuant to federal IRS regulations, and winning Participants are required to cooperate with Casino in completing necessary forms.
9. Promotion times are approximate. Casino reserves the right to change Promotion times due to unforeseen or extenuating circumstances.
10. All decisions regarding the interpretation of these Official Rules, eligibility, etc. for any Promotion lie solely with Casino whose decisions are final.
11. Casino reserves the right to modify or cancel the Promotion at any time, for any reason, subject to any applicable regulatory approval, provided that such modification shall not, as of the date of such modification, materially alter or change any Participant's prize already awarded. Notice of any such modification is sufficient if posted at the Casino's Live Action Registration Area in the Pavilion cash game area.
12. Casino may disqualify any Participant for any prize based upon fraud, dishonesty, violation of these Official Rules or other misconduct while on the property or otherwise occurring in relation to a Promotion or as otherwise reasonable or necessary for Casino to comply with applicable statutes and regulations, in its sole and absolute discretion.
13. Casino is not liable for injuries or losses arising or resulting from participation in any Promotion and is not liable for any acts or omissions by employees, whether negligent or willful, in the conduct of the Promotion and is not liable in the event of any equipment or software malfunction.
14. Casino is not responsible for lost, late, mutilated, or illegible entries nor electronic transmission errors or delays resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, hardware, software, or telephone failures of any kind, lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by Casino, users, or by any of the equipment or programming associated with or utilized in any Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a Participant's ability to participate in any of the Promotions.
15. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Casino which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Promotion, Casino reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion.

16. Any attempt by any person to deliberately damage any program or to undermine the legitimate operation of any Promotion may be a violation of criminal and civil laws and should such an attempt be made, Casino reserves the right to seek damages from any such person to the fullest extent of the law.
17. Prizes and entries are non-transferable.
18. Individuals who are excluded from Casino facilities, either through a government program or by their own request, are not eligible to Participate.
19. Employee Participants must be off the clock and out of uniform during their participation in any Promotion.
 - 19.1. Employee must verify his/her own eligibility per the Caesars Entertainment Team Member Gambling Policy.
20. By entering any Promotion, each Participant agrees on behalf of Participant and his or her heirs, executors, and administrators (a) to release and hold harmless Casino, Promotion Entities, and each of their respective officers, directors, and employees (collectively, "Released Parties") from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from Participant's participation in the Promotion and/or Participant's acceptance, possession, use, or misuse of a prize or any portion thereof (including any travel related thereto); (b) to indemnify Released Parties from any and all liability resulting or arising from Participant's failure to comply with these Official Rules or a breach of any of Participant's representations and warranties; (c) to hereby acknowledge that released parties have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to any prize, including express warranties provided exclusively by a prize supplier that are sent along with such prize; (d) if selected as a winner, to the posting of Participant's name on Casino's websites and the use by the Promotion Entities of Participant's name, voice, image, and/or likeness for publicity, promotional, and advertising purposes in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval, and, upon request, to the giving of consent, in writing, to such use; and (e) to be bound by these Official Rules and to waive any right to claim any ambiguity or error therein or in a Tournament or Promotion itself, and to be bound by all decisions of Casino, which are binding and final.
21. Must be present to win.
22. By participating in a Promotion, Participants agree to comply with all of these Official Rules contained herein.
 - 22.1. A copy of these Official Rules and any changes will be available at Live-Action registration area located in the Pavilion Convention area.
23. Poker play at Promotion eligible tables will be governed by the Official World Series of Poker Live-Action Rules.
 - 23.1. A copy will be available at the Live-Action registration area.
24. Odds of winning certain Promotions are dependent upon number of Participants.

Specific Rules: Hot Seat \$500 Hourly Giveaway:

25. The "Hot Seat \$500 Hourly Giveaway" (hereinafter the "Promotion") refers to the Promotion starting on Monday June 3rd, 2019 at 12:00am and ending on Wednesday July 10th 2019, at 12:00 a.m., occurring daily in the World Series of Poker Live-Action area during the Promotional Period for Limit and No-Limit Live Action poker on designated tables only.
26. Casino shall allocate \$500 (five hundred dollars) per drawing, per hour per day from the World Series of Poker Live Action Games Promotional Fund (the "Reserve") to fund the Promotion. A \$1.00 (one dollar) jackpot promotional fund rake (hereinafter the "Jackpot Rake") will be taken from each pot that reaches \$10.00 (ten dollars) or more at all Live-Action tables that are eligible for the Promotion. This jackpot rake will be collected in the Reserve for the purpose of funding the Promotion.
27. The Drawing will be held each hour on each day starting at 12:00 a.m. only in the event that there is an eligible poker game running. To be eligible for the Drawing, the poker game must contain at least one table, where a Jackpot Rake is being taken, with at least two players at that table. In addition, a player must be actively playing in an eligible game and have no missed blind buttons.
28. The Drawing will be conducted by a computerized random seat generator function in the Bravo PokerWatch software used for Live-Action poker registration. This drawing will include all seats at all eligible Promotion tables.

29. At the time of each drawing if the random seat generator selects a non-eligible winner, the process will be repeated until an eligible seat is drawn.
30. The winner of each drawing shall win \$500 (five hundred dollars) in cash-value Rio casino chips.
31. If there is no eligible game at the pre-assigned drawing time, the money from that particular drawing will be returned to the Reserve.
32. Each drawing will be random and chances of winning are based upon the number of entries.
33. Casino reserves the right to change or cancel the drawing at any time.
 - 33.1. In the event that Promotional funds accumulate in the Reserve, the Casino reserves the right to increase the number eligible seats at any of the eligible drawing times.
 - 33.2. In the event that the Rake accumulated on a daily basis does not reach an average of \$12,000.00 (twelve thousand dollars) per day, the Casino reserves the right to decrease the number of daily drawings by eliminating any of the drawing times throughout the day.
