## A Family Affair for Stephen Binkley Greenbriar, TN native wins his first ring in the \$365 NLHE event.

**Elizabeth, IN (October 9, 2013)** – To say the Binkley family is having a good couple of days at the poker tables would be an understatement. Stephen Binkley and his wife Reyna both played the nightly tournament at the Horseshoe Southern Indiana on Monday night. They were both a part of a five-way chop that netted the pair about 40% of the prize pool. Since then, the couple have parlayed that into two nice scores.

While Reyna is currently the chip leader at the final table of the \$365 No-Limit Hold 'em Event 8, Stephen has won his first Circuit Ring in Event 6, the \$365 No-Limit Hold 'em.

A total of 165 players entered the sixth Circuit ring event at the Horseshoe Southern Indiana. Play ended on Day 1 with just the final table of nine remaining. When Day 2 started, Binkley held nearly 100,000 more chips than his closest opponent.

While the field was whittled down to just the final two players, the chip lead switch to Austin Buchanan, who had a two-to-one chip lead as heads-up play began. Buchanan, a Circuit grinder who was at his eighth career Circuit final table, was looking to secure his first ring as well. Jonathan Taylor, who won the Horseshoe Southern Indiana Casino Championship last year as well as finishing runner-up in the HIS Circuit Main Event in 2012, drove in to support his good friend Buchanan.

Despite being down in chips, Binkley quickly turned the tables on Buchanan and ended up taking the victory after less than an hour of heads-up action. For his victory, Binkley took home \$13,365.

In the last three years, the 43-year old cancer survivor from Greenbriar, TN has cashed on the WSOP Circuit once each year. Despite just three cashes, they have all been final table appearances.

Binkley can now sit back and watch as his wife goes for her first ring today. No matter what happens, it has been quite a couple of days for the Binkley family!

## Notes on the Event

- The final table took just four hours to complete.

- This was the eighth WSOP Circuit final table for runner-up Austin Buchanan.
- Patty Till continues to hold the Casino Champion points lead with 105 points.

With his victory, Binkley earns 50 points towards the Horseshoe Southern Indiana Casino Champion standings. The player who accumulates the most overall points in Horseshoe Southern Indiana's twelve combined gold ring tournaments earns the title Casino Champion and receives an automatic entry into the 2014 WSOP National Championship, as will the winner of the Horseshoe Southern Indiana Main Event. All players who cash in ring events will receive points that apply to both the Casino Champion race and the season-long race to claim one of the at-large National Championship bids awarded to the top point earners throughout the season.
