

## Caesars Interactive Entertainment – WSOP.com BLAST SNG Leaderboards Terms and Conditions Shared Liquidity with New Jersey

As used herein "Casino" means Caesars Interactive Entertainment (CIE) DBA WSOP.com. Promotional period shall begin at 12am 1/5/21 and end at approximately 11:59pm on 2/1/21. All times referred to throughout these Rules are Pacific Standard Time. All references to the BLAST SNG Leaderboards shall be referred to as "Promotion" throughout these Rules.


## **ELIGIBILITY**

- 1. Player eligibility is subject to WSOP.com discretion and the terms and conditions set out below:
- 2. To be eligible for the bonus, a player must have a valid and verified WSOP.com real money account.
- 3. This is a marketing offer that may be offered to selected players via phone, email or other online method, direct mail, or distributed at events.
- 4. Dates and times for this promotion will be provided in the marketing collateral.

## **SPECIFIC RULES**

- 5. Each month's promotion period will consist of four, weekly qualifying periods. Specific dates for each month's qualifying periods will be provided in the marketing collateral.
- 6. Qualifying weeks:
  - o 12am Tuesday, January 5 11:59pm, Monday, January 11
  - o 12am Tuesday, January 12 11:59pm, Monday, January 18
  - o 12am Tuesday, January 19 11:59pm, Monday, January 25
  - 12am Tuesday, January 26 11:59pm, Monday, February 1
- 7. Heads-up (2 player), satellite Sit & Go tournaments, and regular SNG's are not eligible for this promotion and do not award BLAST Leader Board points.
- 8. There will be a high and a low leaderboard that pay out \$500 in BLAST tournament tickets each.
  - Leaderboard for high (\$15/\$30) and low (\$1/\$5) BLAST SNG leaderboards

- 9. Leader boards will be updated daily on the WSOP.com website and will show the top 100 players in each leader board category.
- 10. The formula for calculating a player's rank on each leader board is:



- 11. Points will be awarded to the top 50% of finishers in each qualifying Sit & Go tournament. For instance, in a 4-handed BLAST Sit & Go, the top two finishers will receive BLAST Leader Board points.
- 12. Buy-ins in the above calculation includes WSOP.com fees, as well as the actual buy-in, so a \$0.91 + \$0.09 BLAST SNG would be calculated as \$1 in the above formula.
- 13. The leaderboards will pay the top 10 players their share of \$500 in BLAST tournament tickets each week

- 15. BLAST tournament tickets will be added into a player's account within 72 hour of the player becoming eligible to receive the funds.

- 17. Online tournament tickets will be added to player's account within 72 hour of the player becoming eligible to receive the funds.
- 18. Valid only in Nevada and New Jersey.

## **TAX DOCUMENTATION PROCEDURES**

19. CIE Promotions will retain details of all participants for 60 days after the event. A winners list will be sent to CIE Accounting department, and compared to the above prize matrix. 1099's will be required for each weekly prize over \$600. Documentation will be sent to the CIE Accounting department, and the appropriate tax document will be sent to the winner via secure email. The patron must sign the required tax document and return to the CIE Accounting department prior to the funds and/or prize being released to the patron.
