Terms and Conditions

All times referred to throughout these Rules are Pacific Standard Time. All references to the 2021 Online Bracelet Events shall be referred to as “Tournament” throughout these Rules.

If the game is in progress, the player will be seated; if prior to start, a table will open up within the WSOP.com client when the tournament begins.
- For events that allow re-entry
 - Players who choose to re-enter will have 30 seconds to do so and must have enough money in their bankroll prior to the start of the tournament.
 - Tournament tickets are not available for re-entry

- PLO events not available on mobile.
- Tournament tickets cannot be used for Knock out events which are freezeouts.
