Caesars Interactive Entertainment New Jersey LLC DBA WSOP.com (“CIENJ”) Choose Your Bonus Back refers to the event beginning October 3, 2022 at 12:00am and ends October 17, 2022 at 11:59pm. All times are Eastern.

1. Eligibility

- Subject to WSOP.com discretion, and the terms and conditions set out below.

2. Bonus Back Details

- Promo dates are on October 3, and October 17, 2022.
- Player must click the “Opt-In” link next to the available bonus.
- Players’ earned APPs will determine the Bonus Back they receive.
- APPs for this promotion may only be earned on WSOP Casino games found within the WSOP.com client. APPs earned on Poker do not count for this promotion.
- Players who earn 5 – 100 APPs will be reimbursed 20% of their net cash losses on all games beginning at 12:00am on each promo date and ending at 11:59:59pm on the same day.
 - Minimum amount awarded is \$1 in bonus, which is based on having net cash losses of at least \$5 during the promotional period. Maximum amount awarded is \$10 in bonus, which is based on having net cash losses of \$50 during the promotional period.
- Players who earn 101 – 500 APPs will be reimbursed 50% of their net cash losses on all games beginning at 12:00am on each promo date and ending at 11:59:59pm on the same day.
