

William Hill U.S. Holdco, Inc. – WSOP.com D.I.Y. Bonus Terms and Conditions Shared Liquidity with New Jersey (as permitted by law)

Promotional period shall begin at 12am on 8/9/2022 and end at approximately 11:59pm on 8/23/2022. All times referred to throughout these Rules are Pacific Standard Time. As used herein "Casino" means William Hill U.S. Holdco, Inc. DBA WSOP.com WSOP.com. All references to the D.I.Y. Bonus shall be referred to as "Bonus" throughout these Rules.

Eligibility

SPECIFIC RULES

- 5. Upon opting in, players who earn a certain amount of Action Player Points (APPs) via cash games during the qualifying period will be eligible for one of the below bonuses.
 - 100 APPs -- \$10 Bonus
