Caesars Interactive Entertainment New Jersey LLC DBA WSOP.com (“CIENJ”) WSOP Casino Play & Earn Offer refers to the online event occurring on November 1, 2022 at 12:00am and is ongoing until further notice (the “Promotional Period”). All times are Eastern.

### 1. Eligibility
