As used herein "Casino" means Caesars Interactive Entertainment (CIE) DBA WSOP.com. Promotional period shall begin at 4:00pm on 4/6/2021 and end at approximately 11:59pm on 4/27/2021. All times referred to throughout these Rules are Pacific Standard Time. All references to the Spring Online Championships shall be referred to as "Tournament" throughout these Rules.

A screen will open that contains a "register" button. Upon clicking "register," the player will receive a confirmation. The player will continue registration by clicking "proceed," or "cancel." When successfully registered, the player will see a pop-up indicating successful registration. If the game is in progress, the player will be seated; if prior to start, a table will open up within the WSOP.com client when the tournament begins.

- Redemption: Winning funds will be added to player's bankroll within 7 days once each
 tournament completes. Winner of the Main Event will also receive a Champions Belt.
 Champions belt will be sent to the winners address on file within 10 to 12 weeks once the
 winner has been identified. Delaware players not eligible for receiving the belt.

TAX DOCUMENTATION PROCEDURES

Documentation will be sent to the CIE Accounting department, and the appropriate tax document will be sent to the winner via secure email. The patron must sign the required tax document and return to the CIE Accounting department prior to the funds and/or prize being released to the patron.
