

William Hill U.S. Holdco, Inc. – WSOP.com Vince Vaughn vs The Champions Promotion Terms and Conditions

As used herein "Casino" means William Hill U.S. Holdco, Inc. DBA WSOP.com. Promotional period begins at 12:00am on Vince Vaughn vs The Champions Promotion refers to the event beginning at 12:00am on 11/29/22 ending at approximately 11:59pm on 12/7/22. All times referred to throughout these Rules are Pacific Standard Time.

Terms and conditions for any WSOP.com bonus promotion are to be read in conjunction with the WSOP.com Terms of Service http://www.wsop.com/legal/terms-conditions/, the WSOP.com Bonus Policy http://www.wsop.com/promotions/bonus-policy/ and the General Rules http://www.wsop.com/legal/general-rules.aspx. In the event of a conflict between the Terms of Service, Bonus Policy, general rules and the specific bonus terms herein, the specific bonus terms here in shall prevail.

SPECIFIC RULES

- Subject to WSOP.com discretion, and the terms and conditions set out below, players may receive a Reload Bonus ("Bonus") after they have a fully verified WSOP.com account.
- To be eligible for the Bonus, a player must have a valid and verified WSOP.com real-money
 account. Also, a player is required to deposit a minimum of \$10 ("Qualifying Deposit") and enter
 the given promotional code at the time of the Qualifying Deposit.

- William Hill reserves the right to limit the Bonus to one (1) per player.

- Date and times for this promotion will be included in the marketing materials.

Specific Terms and Conditions:

- Players who make a minimum deposit of \$10 or more with code CHAMP or VINCE during the
 promotional periods (11/29/22 to 12/6/22 by 5:00pm PT) will receive 100% up to \$400 reload
 bonus regardless of if they selected the winning code. The players who deposited with the
 winning code during the promotional period will be given entry in the form of a tournament
 ticket into a \$10,000 Main Event Seat freeroll on December 7 at 5:30pm PT.
- The winning code will be shown on December 6 at 5:00pm PT.
- Only the first deposit code entered will be counted towards the players answer to qualify for the freeroll.
- It is the players responsibility to register for the tournament prior to the start of the tournament.

- To be eligible for the reload bonus, a player must have a valid and verified WSOP.com real-money account. Also, a player is required to deposit a minimum of \$10 ("Qualifying Deposit") and enter the given promotional code at the time of the Qualifying Deposit.

 see a pop-up indicating successful registration. If the game is in progress, the player will be seated; if
 prior to start, a table will open up within the WSOP.com client when the tournament begins.
- The winner of the \$10,000 Main Event Seat Freeroll will receive \$10,000 in buy-in chips to be used towards any Gold Bracelet event at the 2023 World Series of Poker.
- Players may claim their buy-in chips at the 2023 World Series of Poker held at Paris Las Vegas and Bally's Las Vegas. Players must have photo ID and their Caesars Rewards Card to claim their buy-in chips. Any buy-in chips not claimed by the end of late registration on the final event available for registration will be forfeited.
